**AGENDA**

The meeting was called to order by Chairman Don Shonka at 1:30 p.m.

Motion to approve the agenda was made and seconded. Motion passed.

Minutes of the February 26, 2019 meeting were approved as read.

**New Business**

- **Review of By-laws Regarding Officers**

Don Shonka reviewed Article V – Committees and Article VI – Officers in preparation for the election of officers for 7/1/2019-6/30/21.

- **Election of Officers for 7/1/2019-6/30/2021**

A motion was made and seconded to unanimously elect this slate of officers. Motion passed.

- **Update from IIHR/IFC – Antonio Arenas**

Antonio gave a Power Point presentation on the extreme weather conditions in the U.S. and Iowa since June 2018. There has been a 10-20% increase in annual rainfall in Iowa. Bremer received a full year's rainfall in 3 months in 2018.

Very cold temperatures, snow accumulation, accumulation of ice layers in the rivers and highly saturated soils created conditions for flooding.

- **Watershed Planning Updates** – Ross Evelsizer, Northeast IA RC&D

Northeast Iowa RC&D lead the discussion on how the Upper Wapsipinicon River WMA would like to develop goals for the Watershed Resiliency Plan. Four options were outlined by the RC&D as a suggestion on how goals could be developed. Option 1) was to set goals based on the entire watershed area. For example, cover crops on 40% of row crop acres in the Upper Wapsipinicon

River Watershed. Option 2) was to choose the same goals for each HUC 12 Subwatershed. For example, cover crops on 40% of row crop acres in each HUC 12 Watershed. Option 3) was to choose specific goals by HUC 12 based on its location, land cover and land use, geology, soils, etc. Lastly option 4) was to develop goals based on each best management practice. After discussion the Board voted on Option 3 as a means to develop watershed Goals for the Upper Wapsipinicon River Watershed. The Northeast Iowa RC&D Planning Team will be gathering the technical committee to develop the quantitative goals, and will provide materials to inform the goals setting discussion.

Northeast Iowa RC&D reminded WMA board Members to fill out the entity survey discussed at the previous meeting. The survey will help the Planning Team determine who has the resources needed to complete watershed goals and what resources entities need to complete watershed Goals. Northeast Iowa RC&D also asked the Board and meeting attendees for pictures in the Upper Wapsipinicon River Watershed. Pictures of flooding, damage caused by flooding, and pictures of the beautiful watershed in general are needed for the Watershed Plan.

- **Update on IWA Funded Projects – Angie Auel**

A bidding packet with 5 projects has been put together. She is currently working on a list of contractors who will receive the packets. Hope to have packets out for bidding by the end of June. The plan is to begin moving dirt this summer. Grant administrator is working on putting together a bidding packet with 5 projects by fall. There are 405 landowners in HUC 12s.

Angie assisted the Readlyn wetland project with their education package. Teachers received \$5,000.00 to purchase plants for the wetland. Fairbank received \$1,000.00 for a rain garden.

- **Water Monitoring Update 2019 – Angie Auel & Ashley Sherrets**

Angie is coordinating the water sampling program for 2019. Ashley is overseeing 2 volunteers who are obtaining the water samples in Buchanan County. All the counties who have participated in the past are participating again this year.

- **Location of Future Meetings – Discussion**

After discussion, it was agreed that the watershed meetings should continue to be held in Independence.

- **Other**

Iowa Flood Center is celebrating a birthday all day long on Thursday, June 13<sup>th</sup>. Friends, partners, and the general public are invited to participate in a day-long celebration reflecting on their collective achievements over the past 10 years.



Upper Wapsipinicon River


